## Federated Hermes International Strategic Value Dividend Fund

### Access to income with growth potential

Federated Hermes International Strategic Value Dividend Fund offers investors a portfolio of dividend-paying companies outside of the U.S. with strong dividend growth potential.

### Notable highlights

- Federated Hermes International Strategic Value Dividend Fund provided a gross weighted average dividend yield of 4.88% at month-end.
- August 2020 trailing twelve months: 30 companies within the portfolio raised their dividends. Only two companies within the portfolio cut their dividends.

### Consecutive annual dividend payments

Of the 42 stocks in the portfolio:

- 93% have paid consecutive annual dividends for the past 10 years.
- 76% have done so for the past 20 years.
- 29% have notably done so for the past 50 years.

30-day yield (also known as "SEC yield") is a compounded and annualized figure calculated according to a formula set by the SEC. The formula requires use of a specific methodology for calculating dividends and interest earned, and expenses accrued, during the period, and reflects the maximum offering price per fund share. The standardized computation is designed to facilitate yield comparisons among different funds. The figure is compounded and annualized. In the absence of temporary expense waivers or reimbursements, the 30-day yield would have been 3.40% at maximum offering price and 3.61% at net asset value for A Shares, 3.89% for Institutional Shares and 3.90% for R6 Shares.

The fund's R6 Shares commenced operations on June 30, 2016. For the period prior to the commencement of operations of the R6 Shares, the performance information shown is for the fund's Institutional Shares adjusted to remove any voluntary waiver of fund expenses related to the fund's Institutional Shares that may have occurred during the periods prior to the commencement of operations of the fund's R6 Shares.

As of June 29, 2020, the fund was renamed Federated Hermes International Strategic Value Dividend Fund.

The ratings provided are sourced from securities ratings agencies Standard and Poors and Moody's. Standard and Poor's and (Moody's), respectively, make the following credit rating classifications: A (A) or better are considered to be high credit quality; credit ratings of BBB (Baa) are good credit quality and the lowest category of investment grade; credit ratings BB (Ba) and below are lower-rated securities ("junk bonds"); and credit ratings of CCC (Caa) or below have high default risk. A modifier of 1 or + indicates that the obligation ranks in the higher end of its rating category and a modifier of 3 or - indicates a ranking in the lower end of the category.
